

Swim Party Rental Agreement Contract

Swimming Stages Swim Academy (SSSA) will be available to the public on a reservation basis subject to the terms and conditions outlined below.

The applicant granted the reservation agrees to read and abide by the following:

1. User agrees to indemnify and hold harmless SSSA, its agents, and employees from and against any claims for damages to persons or property arising out of any use of SSSA and its premises by users and their guests. SSSA assumes no responsibility for any property placed in or about the facility.
2. No oral agreements for the use of SSSA shall be valid. All reservations must be confirmed with a written contract, signed and approved by SSSA. In addition, no phone applications will be accepted. All contracts and forms must be filled out in person and signed upon booking the party.
3. Party areas are attached to specific time slots to assist with traffic flow in the facility. The user understands and agrees party areas are assigned by the party schedule and therefore cannot be switched or altered. Users wishing to use a specific party area must schedule their party in the time slot available for that area.
4. The fee for a 2 hour party consisting of a maximum of 15 swimmers (including the Guest of Honor) is \$300.00. This includes 2 hours of pool time, as well as party area time. SSSA must be notified at least a week prior to the scheduled party if the number of guests is expected to exceed 20 swimmers. Should the number of swimming guests exceed 20, the user agrees to pay an additional \$5.00 per guest.
5. Party times are limited to 2 hours for all parties.
6. **There will be a \$125.00 non-refundable deposit to book a party.** The user must pre-arrange for payment of the remaining balance of \$125.00 via credit card or post-dated check at the time of booking. SSSA will automatically process all balances 2 weeks prior to the party date. Parties cancelled 2 weeks or less prior to the scheduled date will forfeit the entire fee of \$250. However, should the user need to change the date and/or time of the party they may do so at no extra charge provided the change is made at least 2 weeks prior to the scheduled date. Any date and/or time changes made 2 weeks or less prior to the party will result in a forfeiture of the \$125.00 deposit. In addition, the user will be charged and additional \$125.00 non-refundable deposit for the new date/or time.
7. The user will be responsible for the set up and clean up of the facility. **Set up time is 45 minutes prior to the party.** The user cannot gain access to the party area prior to this time. The user and their guests shall be responsible for clean up, which must be completed before the reserved party time has lapsed. All decorations must be removed and trash disposed of properly.
8. **No confetti, piñatas, noise makers, or glass / ceramic containers allowed. No food, beverage or decorations allowed in the pool area. Concealed weapons and smoking are prohibited anywhere on the premises.**
9. **REUSEABLE SWIM DIAPERS ARE REQUIRED FOR ALL SWIMMERS AGES 3 AND YOUNGER.** Please understand this policy is in place to ensure the health and well-being of our guests and employees. Therefore, there will be **NO EXCEPTIONS**. Thank you in advance for assisting us in keeping our environment clean and safe.
